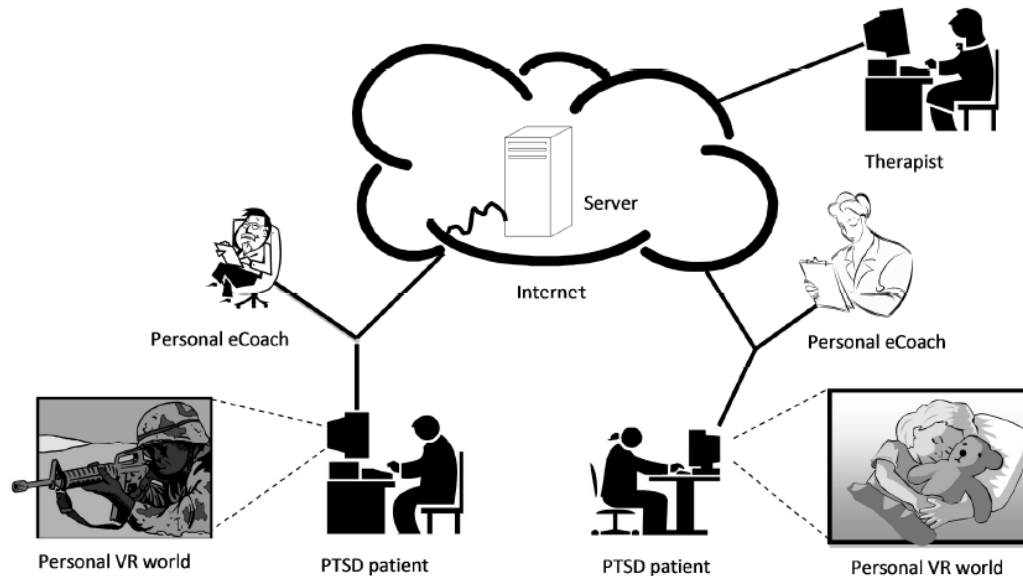

 - Ask suicide-specific question only if existing progress indicate relevant
 - Act when serious suicidal thoughts
 - Automatically contact therapist on risk
